

Fastweb at the Salone della Giustizia (justice exhibition): digital transformation in the service of the legal system

Electronic bracelets with new functions, advanced video surveillance systems for the courtrooms, cloud solutions for process dematerialisation: Fastweb confirms itself as one of the main partners for digital transformation of PA to support the country's legal system.

Milan, 15 May 2018 - Fastweb takes part in the justice exhibition, Salone della Giustizia, opening today in Rome. As part of the exhibition, Fastweb will be taking part on 17 May in the debate "*Magistratura e Media*" ("Judiciary and Media") on the delicate relationship between the judiciary and the media, with special talk on impact in terms of efficiency, security and advantages for citizens deriving from the digitalisation process of Public Administration.

For the Italian Ministry of the Interior, in particular, the new electronic bracelet supply and management contract - which Fastweb has just won - introduces important news in the control of people subject to restrictive measures. The project involves the activation of 1000 electronic bracelets per month - a number far greater than in the previous contract - allowing a significant extension of the use of this tool. Fastweb will supply the entire infrastructure for the connection and remote control of the devices, installing the base stations at the homes of those people under house arrest, connected to the Electronic Monitoring Centre that indicate to the law enforcement authorities if the person subject to the restrictive measure moves away from the range of cover.

Owing to the greater number of devices available and the new functions provided for by the contract, the electronic bracelets will contribute to optimising the management of the supervision measures and restrictive measures, allowing greater guarantees for citizens and relieving the pressure on prisons. The new contract also involves the option to use the bracelets for anti-stalking: the legal authority may impose on the stalker the obligation to wear an electronic bracelet equipped with a GPS device, whereas the potential victim will be equipped with a device able to detect the presence of the stalker nearby and generate an alarm signal to the law enforcement authorities.

Also, with a view to speeding up the digital transformation process, the Italian Ministry of Justice has entrusted to Fastweb, in agreement with CONSIP, the implementation of an advanced video surveillance and video analysis system to boost security in the Italian courts. The project involves the supply of the infrastructure, video cameras and software for the advanced analysis of video flows, able to provide integrated surveillance of the physical areas in question and the relating access. There are multiple fields of application, which will allow analysis and real time indication to the competent organisations of any risk situations, such as fire, public disorder or intrusion attempts and the identification of suspects. This advanced video surveillance system is current in operation in some Italian courts.
