

Swisscom completes the acquisition of Vodafone Italia. Fastweb + Vodafone is born

The integration of high-quality fixed and mobile infrastructures along with the competencies and complementary assets of Fastweb and Vodafone Italia will create a leading converged challenger in the Italian market

Milan, January 2^{nd} , 2025 - Following the closing of the acquisition of Vodafone Italia by Swisscom Group on December 31, 2024, the integration process between Fastweb and Vodafone begins, aiming at the creation of a leading converged challenger in Italy.

Fastweb + Vodafone will unlock significant value for all stakeholders and will have the financial capacity to continue investing in infrastructures and innovation, benefiting the market, consumers, and businesses in Italy thanks to increased scale, a more efficient cost structure and annual run-rate synergies of about 600 million euros enabled by the integration. By combining Fastweb strengths in fixed connectivity with Vodafone Italia leading position in mobile services, Fastweb + Vodafone will offer innovative, competitively priced converged services to families, businesses and Public Administrations, supporting the digital transition of all customers.

With over 20 million mobile and 5.6 million fixed lines, Fastweb + Vodafone becomes the leading infrastructured operator in the Italian telecommunications market leveraging over 20.000 mobile radio sites and a proprietary fixed network of over 74.000 km, enabling mobile and wireline national coverage, 50% of which through FTTH.

Fastweb + Vodafone strategic vision aims at creating value by maintaining significant investments in fixed and mobile infrastructures, focusing on technological innovation and guaranteeing the best service quality and customer experience, while keeping the utmost attention to environmental and social impact.

Walter Renna, Fastweb + Vodafone CEO, comments: "With the official closing, the most important operation of consolidation in the Italian telecommunications market in recent years is completed. We will now start the integration process between the two companies to quickly release its potential and offer even more innovative and high-performance services to customers in all market segments. Fastweb + Vodafone will be a company built on a culture of inclusion and transparency, and where the people, their experiences and expertise are at its core".

Swisscom CEO Christoph Aeschlimann concludes: "I am thrilled about the successful closing, as it strengthens Swisscom Group. The improved positioning in Italy will



create long-term value for all stakeholders - thanks to growing cashflows and dividends in the future."

Fastweb + Vodafone's governance

With the official closing of the transaction, the integration process between Fastweb and Vodafone Italia begins. The two companies will be managed by a unified Executive Committee and will operate under the corporate brand Fastweb + Vodafone; the current brands, such as Fastweb, Vodafone, and ho., will continue to be used commercially. The new Corporate website fastwebvodafone.it is also online starting today.
