**Milan, 20 October 2006** – Verizon Business (NYSE: VZ) and FASTWEB (Milan, MTAX: FWB) have entered into a four-year agreement with Banca Antonveneta (ABN AMRO Group) to link over 1000 branch offices and ATMs across Italy via a fully managed Internet Protocol (IP) Virtual Private Network (VPN).
